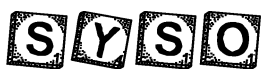

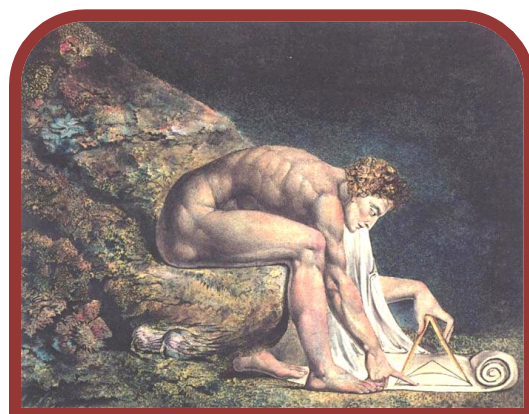

## GRAND LODGE SEATTLE REGIONAL MEETING

The Grand Lodge will hold a Seattle Region #3 meeting at the Scottish Rite Center at 1207 N 152nd just east of Aurora Avenue in Shoreline on Saturday, November 20<sup>th</sup>. ### CHAPTER 6 - MASONIC WORK AND LECTURES

#### Sec. 6.01 Const.

**Standard Work.** The master copy of the combined Esoteric Work, together with the Monitorial Work and amendments thereto adopted by the Grand Lodge, shall be the Standard Work of this Grand Jurisdiction. The Grand Lodge shall print the Esoteric Work in cipher, but with the essential secrets excluded. Every Lodge shall practice that Standard Work and no other.

Work of a recognized foreign Jurisdiction, upon request from the Grand Secretary of that foreign Jurisdiction, review of the proposed ritual by the Grand Lecturer of Washington for reasonable conformity with the Standard Work, and approval of the Grand Master, may be used by members of said foreign Jurisdiction to confer a Degree on the candidate of a Lodge of this Grand Jurisdiction. The candidate must subsequently receive training in and demonstrate proficiency in the Standard Work as provided for in Sec. 20.10 B.L.

1. The Grand Secretary shall be the custodian of the master copy of the Esoteric Work at all times and he shall store the document in a suitable safe within the vaults of his office. The master copy, being for reference only, shall be placed at the disposal of the Craft under such regulations and safeguards, as he shall deem prudent and proper.
2. The Grand Secretary is authorized to make copies of the Standard Work in plain English, including the esoteric work, available for use by the Grand Lecturer, elected Grand Lodge Officers, and by Deputies of the Grand Master in their several Districts, subject to the following: **Rev. 2010**
  - A. The Grand Secretary shall maintain a numbered register of all copies of the Standard Work which shall indicate when and to whom each was issued, and when returned to his custody,
  - B. Each copy of the Standard Work issued to the Grand Lecturer, elected Grand Lodge Officers, and each Deputy of the Grand Master shall be under their direct supervision at all times. It will not be loaned to anyone.
  - C. It shall be a Masonic offense for any Mason other than the Grand Secretary to reproduce the Standard Work in plain English in any medium; and

## Don't Forget you can Buy a Life Membership

*Section 5.* The fee for Life Membership shall be approximately \$150.00 more than those established by the Washington Masonic Code but not less than:

Age 18 through 25	\$900
Age 26 through 35	800
Age 36 through 45	700
Age 46 through 55	650
Age 56 through 65	600
Age 65 and over	550

**The Life Membership Fee is placed in the Lodge's Investment account and only the interest is available for use. Life Members must pay the Grand Lodge annual per capita in order to maintain their lodge status as a Mason in Good Standing.**

## MORE DAYLIGHT HISTORY

**1923 - Harry Lee Carney** Harry Carney was elected Master for 1923 on December 13, 1922 and installed by Ralph Parkhurst on December 27. He was born November 27, 1882 in Sand Lake, Michigan, came to Seattle in 1914, died September 24, 1950. His was amongst the first petitions received by the lodge on April 21, 1920 and he was Raised July 14 of the same year, twelve days too late to be included in the list of charter members. According to Ralph Parkhurst interviewed a short time

before his passing, the original members had purposely held off raising any new candidates until after the charter was granted so that the list of charter members would be limited to those initially involved in putting the lodge together. And Carney was one of those who waited. However he was one of very few early members who obtained a Life Membership in 1928 for the huge amount of \$107.00.

His trade according to the records was *telegrapher* at the *Seattle P.I.* newspaper, which may explain why Parkhurst said that he was an outstanding ritualist, the apparent reason for his having been appointed Senior Deacon in 1921 and his rapid advance to the East. The records show that with the exception of Parkhurst he installed the lodge officers every year until the 1930's, a total of seven different Masters.

At Carney's first meeting the lodge received:

*Communication from a number of Brothers to sponsor the formation of a new Lodge, to be called Elliot Bay Lodge with G. C. Hallett as W.M.; ... was referred to a committee consisting of R. T. Thomas, R. C. Parkhurst & O. R. McLain for investigation.*

At this same meeting there was a resolution submitted to establish a *Permanent Fund*, for investing, etc., the lodge's savings. This was approved on March 14 and made a part of the Bylaws. The request to sponsor Elliot Bay Lodge (which consolidated into St. John's Lodge No. 9 in 1997) was reported on March 14 and the minutes read:

*The Committee appointed to investigate the request of a number of brothers for a Dispensation to form a new Lodge brought in the following Resolution which was adopted: Resolved; That this Lodge do recommend the petition of Brothers ... Praying for a dispensation to establish a new Lodge at Seattle, Wash. by the name of Elliot Bay Lodge, and do avouch for said petitioners as being Master Masons in good standing and recommend that the prayer of the petitioners be granted. That in the judgement of this Lodge, the Brethren named in said Petition as officers of said new Lodge are competent properly to confer the Three Degrees and impart the lectures thereunto appertaining.*

The lodge then went on to other business conferring the Entered Apprentice Degree. On Wednesday, June 27 the lodge celebrated its Third Anniversary with a program of music, speeches and a banquet. Once again the year went by with at least two meetings a month, degrees at nearly every meeting as can be assumed from the fact that twenty seven were held and the membership as of December 31, 1923 reached ninety eight.



To the north of Seattle in Vancouver, British Columbia, 1923 saw the chartering of Meridian Lodge No. 108, AF & AM. Meridian retains its daylight heritage and has been Daylight's true sister lodge for many years. As near as can be determined it was the first daytime lodge in Canada.

In December 1922 Masons in the Vancouver area, once again mostly musicians, met with Right Worshipful Brother E. M. LeFluffy, the District Deputy Grand Master for District 13 to draft a petition signed by fifty members of the

Craft seeking a dispensation to form a daylight lodge. The name selected was Meridian and the communications were to be held on the first and third Thursday of each month. Grand Master A. M. Creery set the lodge under dispensation to work on June 7, 1923. The ritual work chosen by the lodge was the Canadian work.

Meridian's first year included twelve regular meetings and twelve emergent, fourteen candidates for initiation, passed and raised. At year's end the membership was sixty-four, twenty-eight of them being musicians. Like many daytime lodges a small orchestra was started and it played at the 1923 Grand Lodge sessions, for other lodge installation and at events to raise funds for the lodge and the Masonic Service Bureau benevolent funds.

On July 10, 1924 Meridian Lodge No. 108 was constituted. A party at the Hotel Vancouver with the Meridian Lodge orchestra providing the music as the luncheon was served. One hundred and fifty seven attended the luncheon for which the finance committee submitted a bill: **Vancouver Hotel Banquet - \$117.75, Cigars and Cigarettes - \$26.50 and Flowers and tips to waiter - \$19.00, a total of \$163.25.** According to a Meridian Lodge history, fifty years later the Hotel Vancouver estimated that the same event would cost in 1974 prices, \$2819.24.

For many years cab drivers constituted a large part of the membership. As a result Meridian members were active in the Masonic charity program called "The Cancer Car" providing transportation to persons in need of transportation to a Vancouver area hospital.

## NOTICE PROPOSED BYLAWS CHANGE

It has been moved to revise the Lodge Bylaws  
That currently read:

### ARTICLE VII

#### Section 1 - PERMANENT FUND

There shall be a Permanent Fund for the Lodge to which all donations, gifts and bequests given or made to the Lodge by any individual shall be deposited. In addition to the aforementioned gifts, donations and bequests, there shall be paid regularly in to such Fund seventy-five percent (75%) of each Initiation Fee received by the Lodge and all (100%) of the Life Membership fees paid the Lodge.

To read:

### ARTICLE VII

#### Section 1 PERMANENT FUND

There shall be a Permanent Fund for the Lodge. Donations, gifts and bequests given or made to the Lodge by any individual shall be deposited in said Fund if specified by the donor. If not otherwise specified, any donations, gifts or bequests can be used to cover general operating expenses of the Lodge. In addition to the aforementioned gifts, donations and bequests, there shall be paid regularly into said Fund all (100%) of the Life Membership Fees paid the Lodge.

\*\*\*\*\*

This revision will be placed before the Lodge for ballot at this Stated meeting. A two thirds (2/3<sup>rd</sup>) affirmative vote of the members present is required to pass this change.
